REQUEST FOR QUOTATIONS TO DESIGN, SUPPLY AND INSTALL THE NECESSARY INFRASTRUCTURE AND RETICULATION TO PROVIDE BACKUP POWER FROM THE INSTALLED STANDBY GENERATOR TO THE TWO OFFICE BLOCKS IN THE WOMAN'S GAOL AT CONSTITUTION HILL, BRAAMFONTEIN

Constitution Hill is managed as a joint venture between the Johannesburg Development Agency (JDA) and the Blue IQ. The site currently serves a number of purposes including being the home of the Constitutional Court, the site of a number of former prisons which currently plays an educational and heritage role, office space for a number of human rights related organisations, and as a venue for public activities and programmes.

The Constitution Hill Development Company invites quotations to design, supply and install the necessary infrastructure and reticulation to provide backup power from the installed standby generator to the two office blocks in the Woman's Gaol at Constitution hill, Braamfontein as detailed on the attached schedule.

To become a supplier to the Constitution Hill Development Company the attached Application Form must be completed and the relevant documentation supplied for inclusion on the Procurement Database.

The following conditions will apply:

- A valid Tax Clearance Certificate must be submitted
- Price(s) quoted must be valid for at least thirty (30) days from date of your offer.
- Price(s) quoted must be firm and must be inclusive of VAT.
- A firm delivery period must be indicated.
- If the price quoted is above R 30 000 (inclusive of VAT), the quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000). For this purpose the Tax Clearance Certificate, Declaration of Interest and the BEE Forms are attached and must be scrutinized, completed and submitted together with your proposal.
- Factors such as functionality, competence, experience, methodology, skills transfer or creativity as well as price will, where relevant be taken into account in the scoring of a proposal.
- The price cannot exceed R200 000 including VAT.
- The successful provider will be the one scoring the highest points.
