## Tender Notice and Invitation to Tender

The Johannesburg Development Agency invites tenders for BRT 3 Road Underpass Road Upgrade Works

The scope of work comprises existing road widening, upgrading of existing road, construction of a new road section, paved sidewalks, street furniture, street lighting and stormwater drainage provision. It is estimated that the tenderers should have a CIDB contractor grading designation of 5CE or higher.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the Tender Data. Tenderers must be registered with the CIDB in CE class of construction works.

Tenders must submit an original and valid B-BBEE level verification certificate or a certified copy thereof, substantiating their B-BBEE rating.
