

Tender Notice and Invitation to Tender

Request for Proposals for Professionals for Planning, Design and Implementation for the Noordgesig Social Cluster Project

Contract No: **JDA/Noordgesig Social Cluster Project**

The JDA is requesting proposals from Project Managers, Urban Designers/Architects, Civil and Structural Engineers, Quantity Surveyors, Electrical and Mechanical Engineers, Community Participation Consultants and Occupational Health and Safety Consultants who will form the professional team that provides the professional consulting services required for the Noordgesig Social Cluster Project over a period of three financial years.

The City of Johannesburg has embarked on a new spatial vision for the city in line with the Growth and Development Strategy 2040, based on corridor Transit-oriented Development (TOD). The shape of the future city will consist of well-planned transport arterials or "Corridors of Freedom" linked to interchanges focusing on mixed-use developments.

The Noordgesig Social Cluster Project lies within the Soweto Corridor and was identified due to its key linkages to the Noordgesig BRT Station, Soweto Highway and Main Street arterial transport routes.

Individual or multidisciplinary companies and Joint Ventures are eligible to submit tenders, provided that they satisfy criteria stated in the Request for Proposal.
