The Johannesburg Development Agency invites tenders for the construction of the Randburg Precinct Public Environment Upgrade.

It is estimated that tenderers should have a CIDB contractor grading designation of 7CE or higher.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the tender data.

Tenderers must be registered with the CIDB in a CE class of construction works.

Tenders must only be submitted on the tender documentation that is issued. The retyping of the tender document is not permitted.
