

# Tender Notice and Invitation to Tender

## Pre-qualification for the Construction of Drieziek Transport Facility

The Johannesburg Development Agency invites tenders for the construction of the Drieziek Transport Facility which includes sundry civil works, mass earthworks, road preparation and finishes, kerbing and builders work consisting of traditional building methods of open square area, office and ablutions and a huge structural steel and roof sheeting construction over taxi parking areas.

Tenderers are to note that some of the work must be executed by emerging local contractors and it shall also entail the inclusion of City of Johannesburg and SMMEs with a grading of 4CE. It is estimated that each tenderer should have a CIDB contractor grading designation of 7CE and 6CE/PE or higher and NCS-registered contractors will be eligible to tender.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the tender data.
