The Johannesburg Development Agency invites tenders for the upgrading of two intersections including the installation of traffic signals as well as the upgrading of the parking area at the Pirates Club that forms part of a park and ride in the suburb of Greenside in the City of Jo'burg.

The successful tenderer will be expected to manage the component of emerging sub-contractors who will be responsible for executing portions of the work. 30% of the work will be allocated to local emerging SMMEs.

Tenderers should have a CIDB contractor grading designation of 6CE PE or higher.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the tender data.
