Occupational Health and Safety Consultant

The JDA requires the services of a suitably qualified and registered professional Occupational Health and Safety firm to assist in facilitating and ensuring compliance with occupational health and safety regulations in accordance with the latest Occupational Health and Safety Act. In addition the Occupational Health and Safety Consultant will be responsible for developing a comprehensive health and safety specification for the Upgrade of Stadium Avenue and League / National Avenue in Nasrec, undertaking risk identification assessments, evaluation and approval of occupational health and safety plan submitted by contractors and preparation of monthly safety audit reports. The works entail Upgrading of the above roads, paved walkways, streetlighting and street furniture. Duration is 6 months commencing from 05 January 2008.

The full scope of Occupational Health and Safety services required is as follows:

- Prepare the Health and Safety specification for the construction work and provide any principal contractor who is making a bid or appointed to perform construction work for the client with same.
- Take reasonable steps to ensure that each Principal contractor's health and safety plan as determined in regulation 5(1) is implemented and maintained on the construction site: Provided that steps take, shall include audits at intervals mutually agreed upon between the client and Principal contractor, but at least once very month.
- The client, through the appointed health and safety consultant, shall discuss and negotiate with the principal contractor the contents of the health and safety plan contemplated in regulation 5(1) and thereafter finally approve the health and safety plan for implementation.
- The client may appoint an agent in writing to act as his or her representative and where such an appointment is made, the responsibilities as are imposed by these regulations upon a client, shall as far as reasonably practicable, apply to the agent so appointed.

Location

The Nasrec Development Area (NDA) is bounded by Crown Mines Golf Course to the east, Randshow Road to the south, the N1 Concrete high-way to the west and the Soweto Highway to the north. NDA incorporates the Johannesburg Expo Centre and FNB Soccer City.
