The Johannesburg Development Agency invites tenders for the Storm-water Masterplan implementation: Empire Perth Corridor Phase 1B construction (Newclare). The project entails upgrading existing bulk storm water, reinstating damaged sidewalks, damaged kerbs, upgrading street lights, reinstating damaged road layer works, re-surfacing, reinstating damaged speed humps.

The successful tenderer will be expected to manage emerging sub-contractors who will be responsible for executing the portions of the work.

Tenderers should have a CIDB contractor grading designation of 8CE or higher to be eligible to tender. Tenderers must be registered with the CIDB in a CE class of construction work.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the tender data.
