## Rea Vaya Bus Rapid Transport (BRT) System: Phase 1C

### Work Package 15K: Pre-qualification Tender for the Construction of Watt Street Interchange

Contract No: **JDA-WP 15K-01**

The Johannesburg Development Agency invites tenders for a pre-qualification tender for the construction of Watt Street Interchange. This tender has been divided into two stages: Pre-qualification and the pricing stage. The evaluation for this pre-qualification stage will only focus on technical capability/functionality and the pricing will follow in the second stage. Only tenderers who have met the minimum technical requirements will be offered the opportunity for the pricing stage.

The scope of works entails the construction of the BRT link between Arkwright Avenue and Chadwick Avenue along Pretoria Main Road. The scope of works include demolishing the existing bridge and interchange at Watt Street, construction of the new east west link from Rautenbach Avenue to Watt Street with a new at grade intersection on Pretoria Main Road, construction of new BRT lanes and station "underground" below the new at grade intersection with associated structures, lateral support and bulk earthworks. It is estimated that tenderers should have a CIDB contractor grading designation of 9CE.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the tender data.

Documents may be collected Monday to Friday during working hours between 08:00 and 17:00 from Thursday, 15 June 2017.
