The Soweto Stations NMT Links Construction (Mzimhlophe Station)

The Johannesburg Development Agency invites tenders from construction companies for the Soweto stations NMT links construction (Mzimhlophe station). The scope of works entails upgrading/construction of non-motorised transport infrastructure (sidewalks and cycle lanes), re-instatement of damaged road layer works, re-surfacing, re-instatement of damaged speed humps, replacing damaged kerbs, street lighting upgrade along the route, storm-water inlets and storm-water channel.

Tenderers should have a CIDB contractor grading designation of 7CE or higher and 6CE PE. Tenderers must be registered with the CIDB in a CE class of construction work.

The successful tenderer will be expected to manage the sub-contractors (SMMEs) who will be responsible for executing the portions of the work.

Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the tender data.
