Overview

The Johannesburg Development Agency (JDA) in conjunction with the Johannesburg City Parks and Zoo (JCPZ) on behalf of the City of Johannesburg has made significant improvements to one of the most challenged public open spaces in the Inner City of Johannesburg, Pullinger Kop. While key sectorial partnerships are in the process of being finalized for the long-term management of the Park, extensive resident engagement and activation of the park is required to shift the behavior in the Park.

This Park Activation will build on an intensive process of engagement held at End Street North Park and take from lessons learnt from that process. The team is expected to work with the resident group established from that process. The team should support and facilitate the activation in conjunction with this resident group and provide the required resources for the activation events. It is expected that the activation will build towards a plan for the long-term programme of activation which will form part of the long-term management of Pullinger Kop.

1. Location

Pullinger Kop is located in Hillbrow, Inner City Johannesburg, the park in many ways is at the nexus of Doornfontein, Hillbrow and Berea. The Park is park on a ridge and is separated into two sections an upper and lower section:



2. Duration

The estimated period of the plan has been scheduled for completion at the end of June 2017, it is expected to be a 4 month process from the date of the receipt of the Appointment Letter.

3. Professional Team

The lead team member is expected to have at least five years' experience in facilitating complex and diverse stakeholder engagement processes

It is expected that the combined team will have a variety of skills and experience which should include, but is not limited to:

- Community Participation
 - Organisational Development
 - Activation of community sites
 - Community driven projects
 - Events/workshops facilitation
 - Event Organisation
 - Secretariat functionality
 - Fund Raising (where required)

Specific tasks of the team will include:

A. Establishment of Activation Programme for four month process:

- a. Assessment of current activities/initiatives taking place in and around the park to be integrated into the activation programme ;
- b. Together with the Resident Forum and other key stakeholders (including JDA and City Parks and Zoo) decide on the nature of activation events and activities to shift behavior in the Park
- c. Together determine the resources required and sharing of key tasks for the activation programme
- d. Notify local residents of the activation programme

B. Organisation and Facilitation of the Activation Programme

- a. Arrange for a wider group of local stakeholders to be involved in the activation of the Park (Hillbrow Radio, Hillbrow Health precinct, One Love Skating, Djala Nje, George's Boxing School, Outreach Foundation, local artists, dancers, filmmakers, women's groups, choirs, youth groups etc.)

- b. Develop budget for programme of events in the Park, this budget is part of the total fees as per this RFQ and should consider all potential resources from hiring chairs, generators, refreshments etc.

C. Organisational and Institutional Strengthening of the Resident Forum for Park

- a. Assist the Resident Forum to establish a governing structure working with local residents, the City of Johannesburg and private sector players in the area for the co-management and activation of the park

D. Documentation of key lessons learnt towards and recommendations for a long term programme of activation

- a. Using images and inputs during the activation session and reflection sessions with the park forum members during and post-activation event document the successes and lessons learnt
- b. Set out a set of key recommendations for the long-term activation and co-management of the Pullinger Kop Park and identify decide with the Resident Forum who to champion each

Submissions will be evaluated on the criteria to follow:

- Compliant
- Technical
- Price and BBEE status

8.1 Technical

The technical assessment is based on the criteria set-out below.

- 8.1.1 Responsiveness: quotations will be assessed on the completeness and quality of the information requested above. (Weighting 5)
- 8.1.2 Capability: refers to the qualifications and previous relevant experience of the proposed team members. CV's must clearly indicate qualifications; information on what projects the individual has worked on, in what role, duties, and value of project. The information provided will be evaluated in the context of the requirements of the proposed project. (Weighting 15)
- 8.1.3 Previous experience: refers to the bidder's past experience in delivering projects of a similar nature and size to the one being tendered for, in the timeline specified. (Weighting 10)
- 8.1.4 Capacity: relates to the bidder's ability to deliver the project on time, within budget, and according to the required specification. Accordingly the bidder's current commitments, availability of suitably qualified staff to execute the works will be considered, as well as the tenderers financial standing and commercial risk level. (Weighting 20)

Bidders will be required to achieve a minimum score of 70% (350 out of 500) to proceed to price and BBEE analysis.

8.2 BBEE Status

Having completed a technical evaluation, points will be awarded for empowerment (BBEE), in accordance with the Preferential Procurement Regulations 2011 published in Government Gazette No. 34350 dated 8 June 2011. The following table is applicable in this regard:

- 8.2.1 “B-BBEE status level of contributor” means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).
- 8.2.2 Tenderers must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable.
- 8.2.3 An EME must submit a sworn affidavit confirming the following:
- Annual Turnover Revenue of R10 million or less; and
 - Level of Black ownership
 - Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
- 8.2.4 The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and be in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- 8.2.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 8.2.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.
- 8.2.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.
- 8.2.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

8.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- 80 points are assigned to price
- Up to 20 points are assigned to BBBEE status per the table under item 6.2

The total preference points for a tender are calculated with the formula

PP = P_s + P_{bee} Where

PP is the total number of preference points scored by the tenderer

P_s is the points scored for the comparative price of the tenderer, and

P_{bee} is the number of points awarded to the tenderer based on his certified B-BBEE status level

Formula for scoring tender price

The following formula will be used to calculate the points for price.

$$P_s = X \left[1 - \frac{(P_t - P_{\min})}{P_{\min}} \right]$$

Where

P_s = Points scored for comparative price of tender under consideration

P_t = Comparative price of tender under consideration

P_{min} = Comparative price of lowest acceptable tender

X = Points assigned to price

** "Stakeholder" means a person who owns shares in the company and is actively involved in the management of the company or business and exercises control over the company.

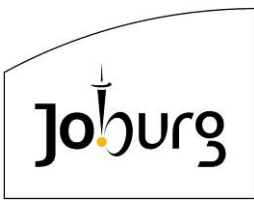
