SUPPLIERS DATABASE REGISTRATION

National Treasury launched the National Central Supplier Database (NCSD) with effect from 1 September 2015.

This will enable prospective suppliers to register their companies on the following website <u>www.csd.gov.za</u>

Transitional Period (1 September 2015 to 30 June 2016)

- 1. During the transitional period suppliers are requested to register on the website where all their essential information such as Tax Clearance Certificates, VAT, Company Registration Numbers and CIPC business status will be verified.
- 2. When conducting business with the JDA, you will be requested to provide us with the following:
 - Supplier Number and;
 - Supplier Registration Security Code so we can print your real time information;
 - Banking details with bank Stamp and;
 - Certified BBBEE Certificate.

Once a supplier has registered on NCSD, it will no longer be a requirement to provide the JDA with an Original Tax Clearance Certificate or any other registration documents.

After Transitional Period 1 July 2016

Effective 1 July 2016, the JDA will only award business to suppliers who are registered on NCSD and suppliers will no longer be required to provide information as stipulated above.

REQUEST FOR FORMAL WRITTEN PRICE QUOTATIONS

Facilitation Services of the JDA's Board Strategic Planning Workshop to be held on 30 and 31 March 2017.

1. SCOPE OF SERVICES

The scope for the services will entail facilitation of the JDA Board's Strategic Planning Workshop.

2. TIME LINES

The two day workshop will be held on 30 and 31 March 2017.

3. THE DELIVERABLES

Deliverables should include:

- Initial engagement with relevant role-players within the JDA, to gather full brief for the session and the necessary background information to support the facilitation.
- Facilitation of the full session
- Collate the issues immerging from the strategy and compile a concise document outlining the board's strategy direction for the JDA
- The number of attendees is up to 25

4. PRESENTATION OF QUOTATIONS

Submissions are to consist of a short **(not to exceed 15 pages)** and comprehensible report that must provide the JDA with sufficient information to make a sound and fair evaluation of the quotation as well as the experience and capability of the applicant to undertake and manage the project successfully. The report should <u>use the same item numbers as below</u> for the required sections of the report.

The following information must be clearly spelt out:

- 4.1 <u>BRIEF</u> company background, lists of <u>SIMILAR (not all)</u> projects (including client name, contact person, telephone number, value of the project, and the consulting fee value, nature of the project, required deliverables).
- 4.2 Provide an organogram for the individuals who will be assigned to <u>THIS PROJECT (not</u> the entire company), note their roles for this project, as well as their relevant qualifications and the number of years of experience in the field. Include detailed CV's of <u>SAID</u> <u>INDIVIDUALS only</u> noting their specific relevant project experience [project description, role and responsibilities, project value]. <u>DO NOT</u> send copies of certificates, testimonials etc.
- 4.3 A valid Tax Clearance Certificate. Bidder will be disqualified if their Tax matters with SARS are not in order.
- 4.4 A copy of the tenderer's municipal rates account for the month of February 2017 in the name of the tenderer <u>or</u> alternatively in the names of the Directors / Partners of the tendering entity. Copies of lease agreements or accounts from a lessor <u>will NOT be accepted</u>.

- 4.5 An original and valid BBBEE status levels verification certificate or a certified copy thereof, substantiating the bidding entities BBBEE rating. Only certificates issued by verification agencies accredited by the South African Accreditation System (SANAS), or by registered auditors approved by the Independent Regulatory Board of Auditors (IRBA) will be accepted. An EME must submit a sworn affidavit confirming the following:
 - Annual Turnover Revenue of R10 million or less; and
 - Level of Black ownership
 - Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
- 4.6 A <u>CERTIFIED COPY</u> of the organisation's Professional Indemnity Insurance indicating the value per claim, excess, and expiry date. If applicable.
- 4.7 An original letter from the tenderer's bank confirming account information.
- 4.8 A statement from an independent auditor / accountant regarding the tenderer's financial standing to undertake this project.
- 4.9 Bidders are required to submit detailed quotations based on the required deliverables [item 3] defined in rand terms. Applicants are to illustrate the fee proposal linked to deliverables. All disbursements, etc. are to be <u>included</u> in the quotations. Applicants must ensure that the <u>TOTAL FEE IS CORRECTLY CALCULATED AND TRANSFERRED TO THE OFFER</u> <u>PAGE</u>.
- 4.10 The attached forms A to F annexed, must be scrutinized, completed and submitted together with your quotation.

Failure to comply with the requirements in item 4 will result in tenderers been negatively scored for responsiveness or disqualified for non-compliance. <u>Note for consortium and joint ventures</u>

- The items above are to be addressed and completed by **<u>EACH</u>** member of the consortium or joint venture.
- An agreement between all parties of the consortium or joint venture is to accompany the tender submission
- A lead consultant is to be appointed and noted in the submission

5. ASSESSMENT CRITERIA

Submissions will be evaluated on the criteria to follow:

- Technical
- BBBEE status
- Price / BBBEE

5.1 Technical

The technical assessment is based on the criteria set-out below.

- 5.1.1 Compliance: tenderers will be disqualified for failure to attach an original and valid tax clearance certificate, for failure to complete the OFFER page in full, for failure to submit a price as requested.
- 5.1.2 Responsiveness: quotations will be assessed on the completeness and quality of the information requested in item 5 above.
- 5.1.3 Capability: refers to the qualifications and previous relevant experience of the proposed team members. CV's must clearly indicate qualifications; information on what projects the individual has worked on, in what role, duties, and value of project. The information provided will be evaluated in the context of the requirements of the proposed project.
- 5.1.4 Previous experience: refers to the bidder's past experience in delivering projects of a similar nature and size to the one being tendered for, in the timeline specified.
- 5.1.5 Capacity: relates to the bidder's ability to deliver the project on time, within budget, and according to the required specification. Accordingly the bidder's current commitments, availability of suitably qualified staff to execute the works will be considered, as well as the tenderers financial standing and commercial risk level.

5.2 BBBEE Status

Having completed a technical evaluation, points will be awarded for empowerment (BBBEE), in accordance with the Preferential Procurement Regulations 2011 published in Government Gazette No. 34350 dated 8 June 2011. The following table is applicable in this regard:

Notes:

5.2.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).

- 5.2.2 Tenderers must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable.
- 5.2.3 An EME must submit a sworn affidavit confirming the following:
 - Annual Turnover Revenue of R10 million or less; and
 - Level of Black ownership
 - Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
- 5.2.4 The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and be in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- 5.2.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.2.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.
- 5.2.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.
- 5.2.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

5.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- 80 points are assigned to price
- Up to 20 points are assigned to BBBEE status per the table under item 6.2

The total preference points for a tender are calculated with the formula

$PP = P_s + P_{bee}$ Where

PP is the total number of preference points scored by the tenderer
 P_s is the points scored for the comparative price of the tenderer, and
 P_{bee} is the number of points awarded to the tenderer based on his certified B-BBEE status level

Formula for scoring tender price

The following formula will be used to calculate the points for price.
