From Consultants to undertake the assessment of the JDA Board Members

1. SCOPE OF SERVICES

The scope for the services will focus on the performance of the Board as a whole, the performance of the Board Sub-Committees and the performance of the individuals against accepted good corporate governance principles and practices.

In particular the appraisal will cover the following areas:

- a) Board responsibilities
- b) Committees of the board
- c) Relationship with management
- d) Board meetings
- e) General observations

2. TIME LINES

The work will be conducted over a period of approximately 3 weeks.

3. THE DELIVERABLES

The scope of work includes but is not limited to:

- 3.1 Create an electronic self-assessment questionnaire that will be completed by the following Board members:
 - 11 x Board members
 - Committees of the board (Audit & Risk, Development & Investment, HR and REMCO and Social & Ethics Committees)
- 3.2 Evaluate and analyse the self-assessment questionnaire;
- 3.3 Conduct interviews of Board members;
- 3.4 Conduct Interviews of Board Sub-Committee members;
- 3.5 Facilitating the administration of completing the questionnaires
- 3.6 Evaluate and analyse the responses of the interviews;
- 3.7 Develop a training plan based on the outcomes;
- 3.8 Prepare a report on action plans and recommendations;
- 3.9 Prepare and present the final results to the Board;

4. PRESENTATION OF QUOTATIONS

Submissions are to consist of a short **(not to exceed 15 pages)** and comprehensible report that must provide the JDA with sufficient information to make a sound and fair evaluation of the quotation as well as the experience and capability of the applicant to undertake and manage the project successfully. The report should **use the same item numbers as below** for the required sections of the report.

The following information must be clearly spelt out:

- 4.1 <u>BRIEF</u> company background, lists of <u>SIMILAR (not all)</u> projects (including client name, contact person, telephone number, value of the project, and the consulting fee value, nature of the project, required deliverables).
- 4.2 Provide an organogram for the **individuals who will be assigned to <u>THIS PROJECT</u> (not the entire company), note their roles for this project, as well as their relevant qualifications and the number of years of experience in the field. Include detailed CV's of <u>SAID INDIVIDUALS only</u> noting their specific relevant project experience [project description, role and responsibilities, project value]. <u>DO NOT</u> send copies of certificates, testimonials etc.**
- 4.3 A copy of a valid Tax Clearance Certificate and Tax Compliant Letter from SARS.
- 4.4 A copy of the tenderer's municipal rates account for the month of April 2016 in the name of the tenderer <u>or</u> alternatively in the names of the Directors / Partners of the tendering entity. Copies of lease agreements or accounts from a lessor <u>will NOT be accepted</u>.
- An original and valid BBBEE status levels verification certificate or a certified copy thereof, substantiating the bidding entities BBBEE rating. Only certificates issued by verification agencies accredited by the South African Accreditation System (SANAS), or by registered auditors approved by the Independent Regulatory Board of Auditors (IRBA) will be accepted. - 4.8 A statement from an independent auditor / accountant regarding the tenderer's financial standing to undertake this project.
- 4.9 Bidders are required to submit detailed quotations based on the required deliverables [item 5] defined in rand terms. Applicants are to illustrate the fee proposal linked to deliverables. All disbursements, etc. are to be **included** in the quotations. Applicants must

4.10 The attached forms A to F annexed, must be scrutinized, completed and submitted together with your quotation.

6. TECHNICAL

The technical assessment is based on the criteria set-out below.

6.1 Technical

The technical assessment is based on the criteria set-out below namely (i) key returnable documents, (ii) capability of the proposed key team members (Capability), (iii) the experience of the company and (iv) contactable references.

Tenderers will have to submit compliant documents and score a minimum number of points in the technical evaluation in order to be considered further in the evaluation process.

The minimum points that bidders must score is 60 points out 100 points (60%) based on the following criteria.

Having completed a technical evaluation, points will be awarded for empowerment (BBBEE), in accordance with the Preferential Procurement Regulations 2017 published in Government Gazette No. 40553 dated 20 January 2017. The following table is applicable in this regard:

- 6.2.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).
- 6.2.2 Tenderers must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable.
- 6.2.3 An EME must submit a sworn affidavit confirming the following:
 - Annual Turnover Revenue of R10 million or less; and
 - Level of Black ownership
 - Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended
- 6.2.4 The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and be in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- 6.2.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 6.2.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.
- 6.2.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.
- 6.2.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

6.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- 80 points are assigned to price
- Up to 20 points are assigned to BBBEE status per the table under item 9.2

The total preference points for a tender are calculated with the formula

PP = P_s + P_{bee} Where

PP is the total number of preference points scored by the tenderer P_s is the points scored for the comparative price of the tenderer, and P_{bee} is the number of points awarded to the tenderer based on his certified B-BBEE status level

Formula for scoring tender price

The following formula will be used to calculate the points for price.

$$P_s = X \left[1 - (\underline{Pt - P_{min}})\right] P_{min}$$

Where

P_s = Points scored for comparative price of tender under consideration

P_t = Comparative price of tender under consideration

P_{min} = Comparative price of lowest acceptable tender

X = Points assigned to price
