We may collect other information in a number of different ways, including:



Using cookies: Cookies are pieces of information stored directly on the computer you are using. JDA will retain Personal Information for the period necessary to fulfil the purpose specified to you unless a longer retention period is required or permitted by law.


JDA will take all reasonable measures to protect the personal information of users. "Personal information" is defined as detailed in both the PAIA and POPI Acts.
