The Johannesburg Development Agency invites tenderers for a **pre-qualification tender** to construct/rehabilitate public spaces. This tender has been divided into two stages, namely technical assessment and the pricing stage. The evaluation for this pre-qualification stage will only focus on technical capability/functionality. The pricing will follow in the second stage. Only bidders who have met the minimum technical requirements will be offered an opportunity to progress to the second stage.

Successful pre-qualification tenderers will be invited to submit priced tenders thereafter.

Tenderers should have a CIDB contractor grading designation of 7CE or higher. Joint ventures are eligible to submit tenders provided that they satisfy criteria stated in the Tender Data.
