The Johannesburg Development Agency invites tenders from construction companies for the public environment upgrade of Mayfair Precinct on Church Street. The scope of works entails upgrading minor storm water infrastructure, sidewalk paving, street lighting and street furniture.

Tenderers should have a CIDB contractor grading designation of 7CE or higher. Tenderers must be registered with the CIDB in a CE class of construction work. Joint ventures are eligible to submit tenders, provided that they satisfy criteria stated in the Tender Data.

Documents may be collected Monday to Friday between 08:00 and 17:00 from Friday, 1 September 2017.
