1. INTRODUCTION

The JDA is requesting proposals from interested and qualified Geotechnical Service provider who is registered with the Engineering Council of South Africa (ECSA) and SANAS registered Geotechnical laboratories for the implementation of the Ivory Park Public Environment Upgrade Projects over a period of 36 Months (March 2021 – March 2024).

2. SCOPE OF WORK AND DELIVERABLES

The Scope of Works includes Public Environment Upgrade (Project 1 - 4) associated with storm water and electrical works as captured above and currently **estimated to cost R 60 Million for the duration of 12 Months.**

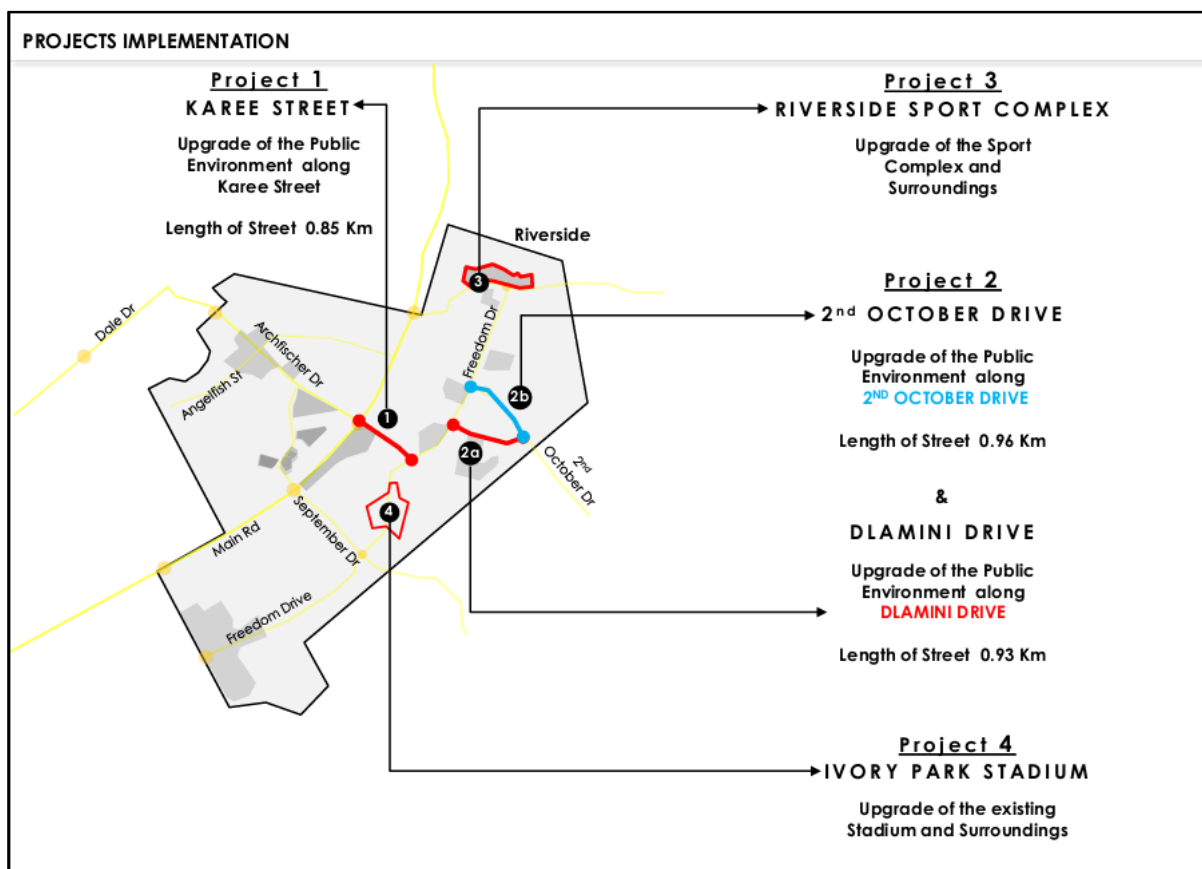


Figure 3: Proposed Areas of intervention

Johannesburg Development Agency (“JDA”) requires the services of Engineering Council of South African (ECSA) registered companies (service provider) and or are SANAS registered Geotechnical laboratories to render geotechnical engineering survey services.

The Geotechnical Engineering Survey Consultant is required to be registered or familiar with acts and code of conduct of an appropriate professional body (i.e. ECSA/Geoscience), and to have the relevant professional accreditation (i.e. registered as Pr. or Pr. Tech Eng./SANAS), skills, experience and capacity to deliver the scope of work within the required time frame.

The Geotechnical Engineering Survey Consultant will be responsible for the survey that will assist the consultant with the design.

2.1 Location and Description

The sites are in Region A of the City of Johannesburg in Ivory Park Township. The project location is illustrated in Figure 3 and roads co-ordinates listed in table 1 below

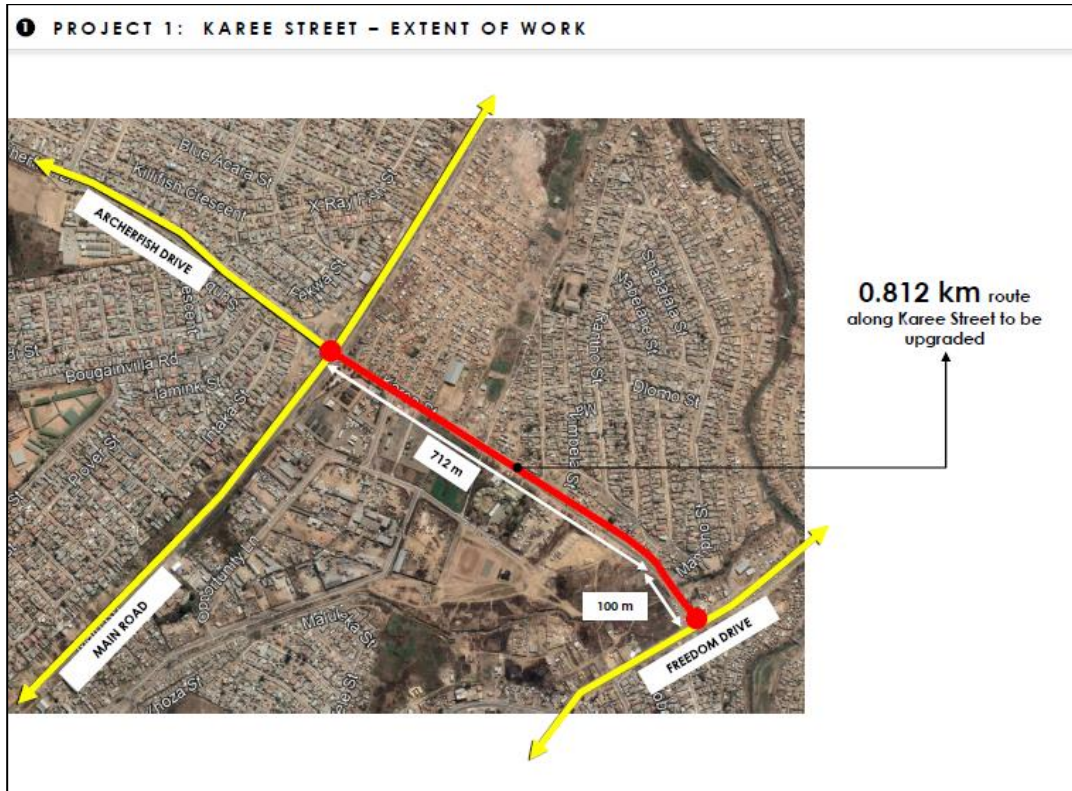


Fig 2.1: Karee Street

2 PROJECT 2: DLAMINI DRIVE & 2ND OCTOBER DRIVE - EXTENT OF WORK

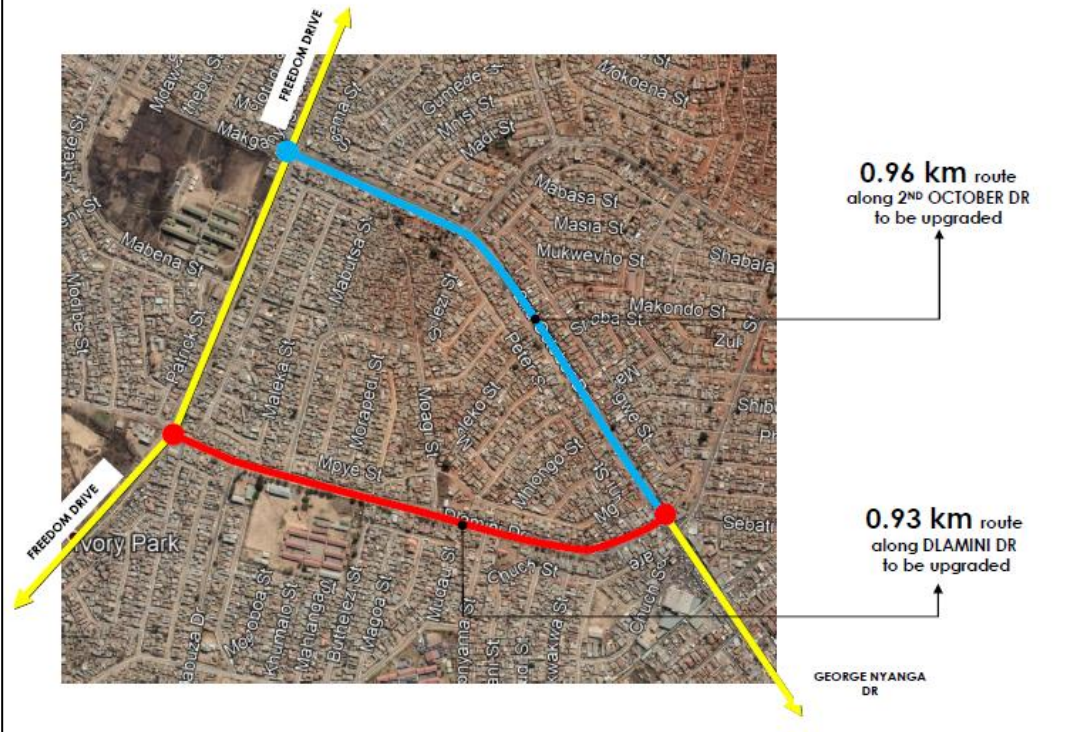


Fig 2.2: Dlamini Drive & 2nd October drive

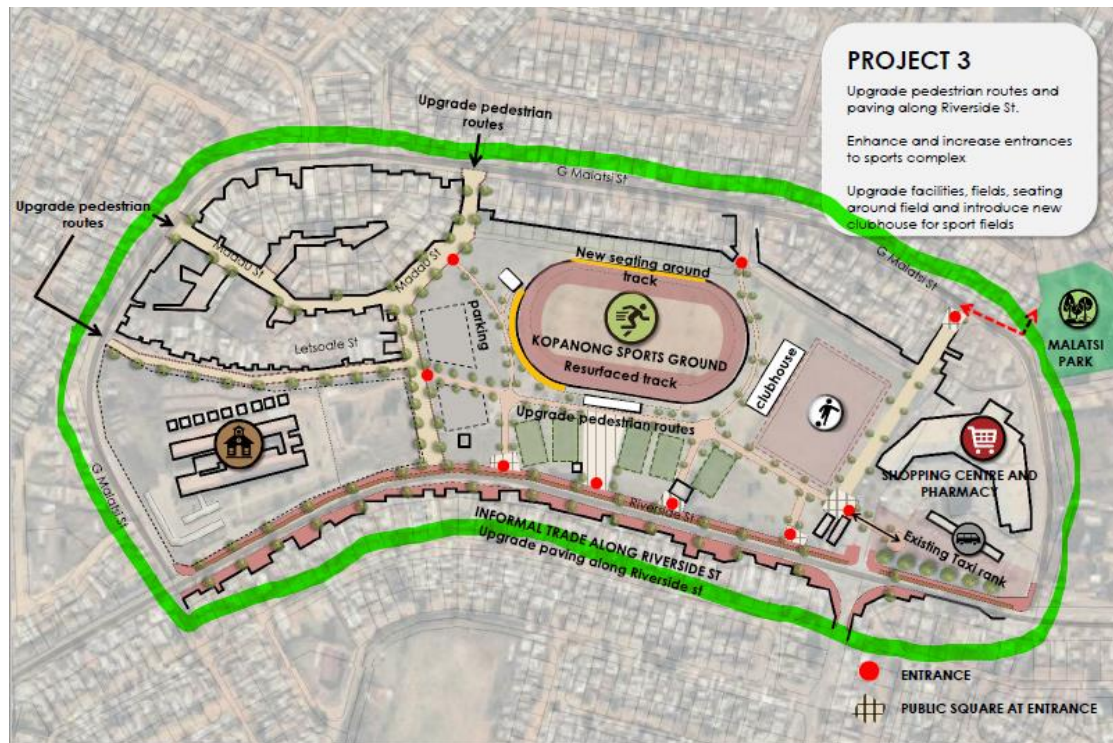


Fig 2.3: Riverside Sport Complex (Kopanong Sports Ground)

THE DETAILED GEOTECHNICAL ENGINEERING SURVEY WILL BE CARRIED OUT AS PER THE FOLLOWING SCOPE OF WORKS:

The scope of the proposed engagement is to provide geotechnical investigation services for the Ivory Park roads and sports field (Karee Street, Dlamini Drive, Ivory Park Sport Stadium and Riverside Sport Complex (Kopanong Sports Ground) in the City of Johannesburg, in Gauteng province Region A.

All work under this contract should be executed in accordance to relevant SANS Codes and to TMH 1: 1986 – Standard Methods of Testing Road Construction Materials, issued by the Committee of State Road Authorities.

The Geotechnical investigation will form part of the inputs of the detail design. The detailed geotechnical investigation and soil tests will be carried out as per the following scope of works:

1. A desk study of available information
2. Test pits to be in wheel track. All test pits will be excavated to a minimum depth of 1200mm.
3. All test pits will be profiled and sampled in accordance to Jennings et al. and industry best practice, then backfilled using material which is of a similar quality as that removed from the relevant horizon. A photograph of each test pit and sample maximum of 4 samples per pit will be provided.
4. For gravel roads, the 150mm horizon will consist of at least G5 material backfilled and compacted to 95% of modified AASHTO density.
5. Traffic accommodation at intrusive testing/sampling sites (Alternatively to be conducted during construction).
6. Do M.D.D and CBR tests (as per layer configuration for each test pit).
7. Do road indicator tests and grading on above samples.
8. Do density tests on above density samples.
9. Moisture content tests on density samples.
10. Dynamic Cone Penetration (DCP) testing will be carried out in accordance with the standard test method. DCP tests should be conducted on the left and right lane wheel paths as indicated on each schedule.

11. Oversee tests and investigations
12. Monitor and value engineer as the full site conditions are exposed.
13. Approvals and recommendations from the Council for Geoscience (CfG) if applicable
The roads and sports facilities that require geotechnical engineering surveys in Ivory Park are listed above in table 2.1

Technical

- 7.2.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.

- 7.2.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

7.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- 80 points are assigned to price
- Up to 20 points are assigned to BBEE status per the table under item 7.2

The total preference points for a tender are calculated with the formula

PP = P_s + P_{bee} Where

PP is the total number of preference points scored by the tenderer

P_s is the points scored for the comparative price of the tenderer, and

P_{bee} is the number of points awarded to the tenderer based on his certified B-BBEE status level

Formula for scoring tender price

The following formula will be used to calculate the points for price.

$$P_s = X \left[1 - \frac{(P_t - P_{min})}{P_{min}} \right]$$

P_s = Points scored for comparative price of tender under consideration

P_t = Comparative price of tender under consideration

P_{min} = Comparative price of lowest acceptable tender

X = Points assigned to price
