**REQUEST FOR FORMAL WRITTEN PRICE QUOTATIONS from Business Management/Development Consultants for the review of the Compliance Management Policy and development of the whistle-blowing policy as part of strengthening Corporate Governance.**

**1. LOCATION**

Policy development and review is desk-top exercise which will be done at the winning bidder office through a consultation process with key Johannesburg Development Agency (JDA) personal.

**2. SCOPE OF WORK**

2.1 The scope requirement is the review of the Compliance Management Policy that adequately address compliance matters relative to a municipal entity and the adopted methodology/procedure of ensuring compliance. Policy should take into to account the findings raised by auditors but should not be necessarily limited to addressing auditing findings.

2.2 Development of a Whistle-blowing Policy that is linked to the City of Johannesburg (CoJ) hotline and adequately address the reporting procedure of an impropriety, fraudulent or corrupt activity. Policy should seek to cover all significant areas that will capacitate a layman to report any perceived or detected impropriety.

**3. DURATION**

The estimated period of the review and development policies has been scheduled for 3 weeks from the date of the receipt of the Purchase Order/Appointment Letter to final output delivery.

**4. THE DELIVERABLES**

- 4.1 Reviewed Compliance Management Policy
- 4.2 Developed Whistle-blowing Policy

**5. PROPOSAL CONTENT**

The bidder's submission must provide the JDA with sufficient information to enable the employer to make a sound and fair evaluation of the proposal. It must clearly indicate the **relevant** previous experience, capability, and capacity of the bidding entity to undertake the project. The proposal should **use the same item numbers as below.**

The following minimum documentation must be provided :

- 5.3. **A valid Tax Clearance Certificate. Any bidder who fails to do so will be disqualified.**
- 5.4. Company registration documents.
- 5.5. A certified and valid BBBEE status level verification certificate or a certified copy thereof, substantiating the bidding entities BBBEE rating. Only certificates issued by verification agencies accredited by the South African Accreditation System (SANAS), or by registered auditors approved by the Independent Regulatory Board of Auditors (IRBA) will be accepted.
- 5.6. A certified copy of the bidder's Professional Indemnity Insurance certificate indicating the maximum value per claim in an insurance period, the applicable excess, and the expiry date. A minimum cover of R1m is required for this project. (If applicable)
- 5.7. Latest copy of the bidding entity's municipal rates account in the name of the bidding entity or alternatively in the names of the directors / partners of the bidding entity. Copies of lease agreements or accounts from a lessor **will not be accepted.**
- 5.8. A statement from an independent auditor / accountant regarding the tenderer's financial standing to undertake this project.
- 5.9. Details of directors / partners / members and shareholders.
- 5.10. Certificates of membership/s to industry bodies.(If applicable)
- 5.11. A corporate brochure. Alternatively a brief summary of the entity's background.
- 5.12. A schedule of completed contracts of a **similar** nature to this project. The following details **must** be included on the schedule :
  - Description of the project
  - Service rendered
  - Name of employer / client and their representative's contact details
  - Cost of the works (project construction value)
  - Fee obtained for services

- 5.13. Provide information on the individuals who will be assigned to **this project (NOT the entire company)**. The following **must** be addressed :
  - role/s and responsibility/ies on this project
  - relevant qualifications
  - number of years of relevant experience in the industry and in the proposed role
  - a percentage estimate of the time planned to be dedicated to this project by each person
  - detailed CV's for each member of the team noting their specific relevant project experience [project description, role and responsibilities, project value].

- 5.14. A detailed approach and methodology statement wherein the approach to be followed in each stage of the design and construction process is outlined with clear identification of the deliverables in each stage. This section should show the tenderer's understanding of the process and input required towards the completion of the required services.
- 5.15. The forms A to E annexed, must be scrutinized, completed in full and submitted together with your quotation.

**Failure to comply with the requirements in item 5 will result in tenderers been negatively scored for responsiveness or disqualified for non-compliance.**

**Note for consortium and joint ventures**

- The items above are to be addressed and completed by **EACH** member of the consortium or joint venture.
- An agreement between all parties of the consortium or joint venture is to accompany the tender submission
- A lead consultant is to be appointed and noted in the submission

## **6. ASSESSMENT CRITERIA**

Submissions will be evaluated on the criteria to follow:

- Technical
- BBBEE status
- Price / BBBEE

### **6.1 Technical**

The technical assessment is based on the criteria set-out below.

- 6.1.1 Compliance: tenderers will be disqualified for failure to attach an original and valid tax clearance certificate, for failure to complete the OFFER page in full, for failure to submit a price as requested.
- 6.1.2 Responsiveness: quotations will be assessed on the completeness and quality of the information requested in item 5 above.
- 6.1.3 Capability: refers to the qualifications and previous relevant experience of the proposed team members. CV's must clearly indicate qualifications; information on what projects the individual has worked on, in what role, duties, and value of project. The information provided will be evaluated in the context of the requirements of the proposed project.

6.1.4 Previous experience: refers to the bidder’s past experience in delivering projects of a similar nature and size to the one being tendered for, in the timeline specified.

6.1.5 Capacity: relates to the bidder’s ability to deliver the project on time, within budget, and according to the required specification. Accordingly the bidder’s current commitments, availability of suitably qualified professionals to execute the works will be considered, as well as the tenderers financial standing and commercial risk level.

**6.2 BBBEE Status**

Having completed a technical evaluation, points will be awarded for empowerment (BBBEE), in accordance with the Preferential Procurement Regulations 2011 published in Government Gazette No. 34350 dated 8 June 2011. The following table is applicable in this regard :

Notes :

- 6.2.1 “B-BBEE status level of contributor” means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act ( Act No.53 of 2003).
- 6.2.2 Tenderers must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable.
- 6.2.3 Bidders with annual total revenue of R5 million or less qualify as exempted and must submit a certificate ; issued by a registered auditor, accounting officer or an accredited verification agency.
- 6.2.4 The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and be in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- 6.2.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 6.2.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

6.2.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.

6.2.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

### 6.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- 80 points are assigned to price
- Up to 20 points are assigned to BBEE status per the table under item 6.2

The total preference points for a tender are calculated with the formula

$$PP = P_s + P_{bee}$$

Where

**PP** is the total number of preference points scored by the tenderer

**P<sub>s</sub>** is the points scored for the comparative price of the tenderer, and

**P<sub>bee</sub>** is the number of points awarded to the tenderer based on his certified B-BBEE status level

#### Formula for scoring tender price

The following formula will be used to calculate the points for price.

$$P_s = X \left[ 1 - \frac{(P_t - P_{min})}{P_{min}} \right]$$

Where

**P<sub>s</sub>**= Points scored for comparative price of tender under consideration

**P<sub>t</sub>**= Comparative price of tender under consideration

**P<sub>min</sub>**= Comparative price of lowest acceptable tender

**X = Points** assigned to price
