## REQUEST FOR FORMAL WRITTEN PRICE QUOTATIONS: REPAIRS TO BUS FACTORY GUTTERS

Kindly furnish me with a written quotation for the supply of the goods/services of the following:

The JDA requires a service provider to repair three gutters within the Bus Factory building:

- Redesign and replace all catch boxes between the gutters and the downpipes;
- Enlarge gutter openings into catch boxes and secure/seal all joints;
- All three gutters and the new catch boxes must be treated with rust inhibitors and waterproofed with a suitable product;
- A recommendation must be given whether the inserts of the most southern gutter should be removed or not;
- A guarantee must be provided on all work done.

It is essential that interested service providers conduct an on-site inspection of the relevant areas of the Bus Factory. Please arrange this directly with Mr Neels Reyneke (office) 011 688 7881 (cell) 079 888 5542.
