Request for Proposals for Civil and Traffic Engineers and Urban Designer for the Design and Implementation of Greenstone Terminal, Emthonjeni Terminal and Ghandi Square Interchange

Tenderers are invited to submit proposals for the design and implementation of the Rea Vaya Phase 1C Terminals for Greenstone Terminal, Emthonjeni Terminal and Ghandi Square Interchange, located in Modderfontein, Ivory Park in Tembisa Township and Johannesburg CBD, respectively. The work comprises the design of a high quality integrated transport interchange. The scope entails design of loading and offloading bays for buses, bus circulation bays, a pedestrian concourse, BRT ticket office and commuter information centre, bicycle storage area, soft and hard landscaping, CCTV cameras and all requisite electrical and mechanical services. The proposal must include all services required to deliver the above stated scope of works as stated below.

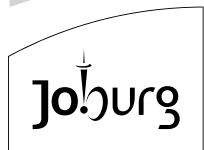
